King St. and Malaga St. Construction Project

On Monday, Jan. 31, Malaga St. will be reopened at King St. The eastbound King St. detour, between US 1 and Malaga St. will be shortened to allow traffic from Malaga St. and Sebastian Harbor Dr. to turn east or west onto King St. Eastbound King St. traffic, between US 1 and Malaga St. will continue to be detoured at US 1 to West Castillo to A1A to Cathedral Pl. to Cordova St. and back to King St. through early April.
